**STATEMENT OF CHARGES and SETTLEMENT AGREEMENT
(Combined)**

COMES NOW the Iowa Board of Medicine (Board), and Gary L. Berg, M.D., (Respondent), on July 10, 2008, and pursuant to Iowa Code sections 17A.10(2) and 272C.3(4)(2007), file this combined Statement of Charges and Settlement Agreement.

STATEMENT OF CHARGES

1. Respondent was issued Iowa medical license no. 25607 on July 17, 1986.
2. Respondent's Iowa medical license is active and will next expire on August 1, 2009.
3. The Board has jurisdiction pursuant to Iowa Code chapters 147, 148 and 272C.

COUNT I

4. Respondent is charged pursuant to Iowa Code section 148.12 and 653 IAC 23.1(38) with entering into a voluntary agreement to restrict the practice of medicine in another state, district, territory, or country, in violation of the laws and rules governing the practice of medicine in Iowa.

STATEMENT OF THE MATTERS ASSERTED

5. On May 16, 2007, Respondent entered into a formal non-disciplinary Consent Agreement with the Arizona Medical Board that restricted his medical practice. Respondent voluntarily agreed not to practice medicine due to a medical condition that may limit his ability to safely engage in the practice of medicine.

SETTLEMENT AGREEMENT

6. **VOLUNTARY SURRENDER:** Respondent voluntarily surrenders his Iowa medical license to resolve this matter.

7. Respondent shall obey all federal, state and local laws, and all rules governing the practice of medicine in Iowa.

8. This Order constitutes the resolution of a contested case proceeding.

9. By entering into this Order, Respondent voluntarily waives any rights to a contested case hearing on the allegations in the Statement of Charges, and waives any objections to the terms of this Settlement Agreement.


10. Respondent voluntarily submits this Order to the Board for consideration.

11. This Order is subject to approval of the Board. If the Board fails to approve this Order it shall be of no force or effect to either party.

12. The Board's approval of this Order shall constitute a **Final Order** of the Board.


