STATEMENT OF CHARGES AND SETTLEMENT AGREEMENT
(Combined)

COMES NOW the Iowa Board of Medicine (Board) and Todd W. Gray, M.D., (Respondent), on August 28, 2015, and pursuant to Iowa Code sections 17A.10(2) and 272C.3(4) and 653 IAC 25.3, enter into this combined Statement of Charges and Settlement Agreement.

STATEMENT OF CHARGES

1. Respondent was granted Iowa medical license no. 38691 on November 3, 2009.
2. Respondent's Iowa medical license is active and will next expire on November 1, 2016.
3. The Board has jurisdiction in this matter pursuant to Iowa Code chapters 147, 148 and 272C.

COUNT I

4. **Prescribing to a Member of Your Immediate Family:** Respondent is charged pursuant to Iowa Code section 148.6(2)(i) and 653 IAC 23.1(7) with prescribing controlled substances to a member of his immediate family in violation of the laws and rules governing the practice of medicine in Iowa.

STATEMENT OF MATTERS ASSERTED

5. **Practice Setting:** Respondent is an Iowa-licensed physician who practices internal medicine in Washington, Iowa.

6. **Prescribing to a Member of Your Immediate Family:** The Board alleges that Respondent prescribed hydrocodone, a controlled substance, to his elderly mother between January 2012 and April 2014 in violation of the laws and rules governing the practice of medicine in Iowa. Respondent denied knowledge of the rule which prohibits physicians from prescribing controlled substances to members of their immediate family except for an acute condition or on an emergency basis when the physician conducts an examination, establishes a medical record, and maintains proper documentation.

SETTLEMENT AGREEMENT

7. **CITATION AND WARNING:** Respondent is hereby **CITED** for prescribing controlled substances to his mother between January 2012 and April 2014 in violation of the laws and rules governing the practice of medicine in Iowa. Respondent is hereby **WARNED** that violation of the laws and rules governing the practice of medicine in the future may result in further discipline against his Iowa medical license.

17. This Order is subject to approval of the Board. If the Board fails to approve this Order it shall be of no force or effect to either party.

18. The Board's approval of this Order shall constitute a **Final Order** of the Board.




