CONSENT AGREEMENT

COMES NOW the Iowa Board of Medicine (Board) and Raphael N. Ngengwe, M.D. (Applicant) on December 6, 2011, and enter into this Consent Agreement granting Applicant a permanent Iowa medical license subject to the following conditions:

1. Applicant is hereby granted Iowa permanent medical license no. 39942.
2. Applicant completed an internal medicine residency in Cleveland, Ohio, on June 30, 2006.
3. Applicant entered a cardiovascular medicine fellowship on July 1, 2007.
4. Applicant was placed on probation on two occasions during his cardiovascular medicine fellowship due to concerns about his professionalism.
5. Applicant withdrew from the fellowship in January 2010.
6. Applicant applied for a permanent Iowa medical license on June 17, 2011.
7. At the request of the Board, Applicant completed a Forensic Professional Fitness Evaluation at Acumen Assessments, LLC. in October 2011.

CONSENT AGREEMENT

8. **CITATION AND WARNING:** Respondent is hereby **CITED** for repeated lack of professionalism during his cardiovascular medicine fellowship training. Respondent is hereby **WARNED** that further issues related to professionalism may result in further disciplinary action, including suspension or revocation of his Iowa medical license.

9. **IPHP REFERRAL:** Prior to the Board's approval of this Order and granting Applicant an Iowa medical license, Respondent shall enter into a Physician Health Contract with the Iowa Physician Health Program (IPHP) for monitoring. Applicant shall fully comply with the terms and conditions of the Physician Health Contract. If Respondent fails to fully comply with all requirements of the Physician Health Contract, the Board may initiate action to suspend or revoke Respondent's Iowa medical license or to impose other license discipline as authorized in Iowa Code Chapters 148 and 272 and 653 IAC 24.

10. Applicant voluntarily submits this Consent Agreement to the Iowa Board for consideration.

11. Applicant shall obey all federal, state and local laws, and all rules governing the practice of medicine in Iowa.


12. This Consent Agreement constitutes the resolution of a contested case proceeding.

13. In the event Applicant violates or fails to comply with any of the terms or conditions of this Consent Agreement, the Iowa Board may initiate action to suspend or revoke the Applicant's Iowa medical license or to impose other license discipline as authorized in Iowa Code chapters 148 and 272 and 653 IAC 25.

14. By entering into this Consent Agreement, Applicant voluntarily waives any right to a contested case hearing in this matter.


15. This Consent Agreement is subject to approval of the Iowa Board. If the Iowa Board fails to approve the Order, it shall be of no force or effect to either party.

16. The Iowa Board's approval of this Consent Agreement shall constitute a **FINAL ORDER** of the Iowa Board.


