CONSENT AGREEMENT

COMES NOW the Iowa Board of Medicine (Board) and James H. Price, Jr., D.O. (Applicant) on September 25, 2012, and enter into this Consent Agreement for the issuance of a permanent Iowa medical license subject to the following terms and conditions:

1. Applicant is hereby granted Iowa permanent medical license no. 4359, to practice medicine and surgery in Iowa.
2. Applicant currently practices anesthesiology in Vail, Colorado.
3. On March 22, 2012, Applicant submitted an application for a permanent Iowa medical license.
4. On April 1, 2004, Applicant was disciplined by the Alaska State Medical Board for submitting a false report to a patient's employer. The patient, who was also a friend of Applicant, had been drinking alcohol and was impaired. The patient contacted Applicant by telephone requesting a note stating that the patient was fit to return to work.

Applicant faxed a note to the patient's employer stating that the "patient was examined by me and is determined healthy to return to work..." Applicant had not conducted an examination as indicated in the note that he submitted to the patient's employer. The patient presented to work impaired. The Alaska State Medical Board issued Applicant a public reprimand and ordered him to pay a \$5,000 fine. \$2,000 of the fine was suspended due to no further violations.

5. **CITATION AND WARNING:** Applicant is hereby **CITED** for being disciplined by the Alaska State Medical Board for submitting a false report to a patient's employer. Applicant is hereby **WARNED** that evidence of such conduct in the future may result in further disciplinary action, including suspension or revocation of his Iowa medical license.

6. Applicant shall obey all federal, state and local laws, and all rules governing the practice of medicine in Iowa.

7. This Consent Agreement constitutes the resolution of a contested case proceeding.


8. Applicant voluntarily submits this Consent Agreement to the Iowa Board for consideration.

9. By entering into this Consent Agreement, Applicant voluntarily waives any right to a contested case hearing in this matter.

10. This Consent Agreement is subject to approval of the Iowa Board. If the Iowa Board fails to approve the Order, it shall be of no force or effect to either party.

11. The Iowa Board's approval of this Consent Agreement shall constitute a **FINAL ORDER** of the Iowa Board.
