CONSENT AGREEMENT

COMES NOW the Iowa Board of Medicine (Board) and John Wassner, M.D. (Applicant) on December 8, 2014, and enter into this Consent Agreement for the issuance of a permanent Iowa medical license subject to the following terms and conditions:

1. Applicant is hereby granted reinstatement of his permanent Iowa medical license no. MD-19593.
2. On June 20, 2014, Applicant submitted an application for reinstatement of his permanent Iowa medical license.
3. **New Mexico Disciplinary Action:** On October 3, 2013, Applicant entered into a Stipulation of Licensure and Order with the New Mexico Medical Board (New Mexico Board). The New Mexico Board alleged that the Applicant failed to report an adverse action taken by a health care entity in violation of the New Mexico Board's Medical Practice Act. The New Mexico Board issued Applicant a public reprimand.

4. **CITATION AND WARNING:** Applicant is hereby **CITED** for being disciplined by the New Mexico Board for failing to report an adverse action taken by a health care entity in violation of the New Mexico Board's Medical Practice Act. Applicant is hereby **WARNED** that violating the laws and rules governing the practice of medicine in Iowa in the future may result in further disciplinary action against his Iowa medical license.

5. Respondent voluntarily submits this Order to the Board for consideration.

6. Respondent agrees that the State's counsel may present this Order to the Board for consideration.

7. By entering into this Order, Respondent understands that he has the right to legal counsel in this matter and waives any objections to the terms of this Order.

8. Respondent shall obey all federal, state and local laws, and all rules governing the practice of medicine in Iowa.

9. Respondent understands that the Board is required by Federal law to report this action to the National Practitioner Data Bank.

10. This Order becomes a public record available for inspection and copying upon execution in accordance with the requirements of Iowa Code Chapters 17A, 22 and 272C.


11. This Order is subject to approval of the Board. If the Board fails to approve this Order it shall be of no force or effect to either party.


