I. Minutes

On a motion by Tom Drew, and a second by Rod Zeitler, M.D., the Board voted to approve the Board meeting closed minutes for December 29, 2009 and the Board meeting public session minutes for August 20, 2010.

II. Consideration of the Settlement Agreement in the Matter of Robert A. Bischoff, M.D., Respondent, File No. 02-07-293
