G. Administrative Rules

1. Report on Public Hearings:

- ARC 9413B (Mandatory CME for chronic pain management and end of life care)

Written and in-person comments were received. Board staff will meet May 5 with stakeholders, including IMS and IOMA, for further discussion on the proposed rule. Any changes to the

noticed rule are expected to be presented at the June Board meeting. Dr. Olds discussed physician education for pain management and hospice care. He suggests 2 hours of CME credit for each course be required every five years.

- ARC 9414B (Physician-patient agreements, drug-testing, prescription monitoring program)

Leah McWilliams, IOMA, made comments regarding application of the physician-patient agreement for patients in nursing homes and hospice. Kent Nebel, Director of Legal Affairs, stated that proposed amendment could be altered to possibly waive that requirement when a physician is treating patients in these settings.

- ARC 9415B (Grounds for discipline for failing to report HIV/HBV status) was not discussed.

2. Proposed amendments for IAC 653-22.1 (Mandatory reporting)

The Board is not ready to present this amendment.

On a motion by Colleen Stockdale, M.D., and a second by Paul Thurlow, the Board voted to delete the proposed amendments for IAC 653-22.1.

3. Executive Order No. 71 (Assessing a rule's impact on jobs)

Executive Director Mark Bowden advised the Board of the Governor's order, which requires agencies to add an impact statement on jobs in the preamble when proposing new rules.

H. Legal update/issues

Julie Bussanmas, Assistant Attorney General, discussed the use of alternate Board members on hearing panels. When Board staff is assembling a panel for a hearing, the Board members are to be contacted first. Alternates will be notified to complete the quorum should Board members are not available. No more than two alternate Board members can be on a hearing panel. It was also noted that a hearing panel must have a majority of physicians.

Updates were provided on pending court cases.

I. Enforcement Update

Russell Bardin, Chief Investigator, stated that 20 percent of the enforcement cases are now less than two years old.

J. Telemedicine

1. FSMB Telemedicine Conference

Kent Nebel, Director of Legal Affairs, reviewed the telemedicine conference he attended on March 10, 2011, in Washington, DC. Discussed at the conference: The need for uniform licensure and telemedicine standards; telemedicine is adding to the scope of practice discussion inasmuch as it can require more collaboration among various health care providers; and areas of Potential Cooperation between state medical boards.

K. Iowa Physician Health Program

1. Statistical Report

On April 1, 2011, there were 89 participants in the program.

2. Appointment of New IPHC Member

The Iowa Physicians Health Committee (IPHC) interviewed Sasha Khosravi, D.O., on March 4, 2011, for a position on the committee. Dr. Khosravi is a child psychiatrist. Dr. Vista-Wayne recommended Dr. Khosravi's appointment to the committee. With Dr. Khosravi's appointment, there would be eight members on the committee.

Executive Director Mark Bowden noted that the study reinforced the importance of physician education in stemming patient abuse and diversion of controlled substances. He noted that the Board had distributed more than 750 copies of "Responsible Opioid Prescribing: A Physician's Guide."
