Chair's Report

Siroos Shirazi, M.D., Board chair, recognized Rodney Zeitler, M.D., Iowa City, former Board member for his service on the Board, June 22, 2007, through April 30, 2011.

Executive Director's Report

The Department of Management has approved requests to fill three vacant positions: investigator, clerk-specialist (licensure) and program planner 2 (monitoring case manager). The hiring process should begin by August 15. Eric Way, secretary 1 (licensing assistant) resigned July 18 to accept an information technology position with the Iowa Board of Pharmacy on August 5. A request to fill this vacancy will be filed by August 15.

The Board's regulatory plan for FY2012 has been submitted to the Iowa Department of Public Health and has been posted on the Board's website, www.medicalboard.iowa.gov. The plan reflects the Board's priorities, but it is subject to change as circumstances dictate.

The Governor's Office of Drug Control Policy is establishing an advisory task force to look at possible state response to the problem of prescription drug abuse and diversion. The Board has been asked to participate and will be represented by the Executive Director. The task force will meet Aug. 3, Sept. 13 and Oct. 11. The task force will present its recommendations to the Governor by Nov. 1.

Theresa Weeg, Assistant Attorney General, provided information regarding the meeting that was held July 12, 2011, with the administrative law judges regarding their concerns about the space and set-ups for hearings in the conference room at the Board's administrative office, 400 SW Eighth Street, Des Moines.

She also advised the Board that plans were being made to provide training for investigators later this year.

Enforcement Update

Russell Bardin, Chief Investigator, provided an overview of Enforcement activities.

Iowa Physician Health Program (IPHP)

The IPHP statistical report for June and July 2011 were shared along with the Annual Fiscal Year 2011 Report.

Board members will be meeting with the Iowa Physician Health Committee on September 22, 2011.

Federation of State Medical Boards (FSMB)

FSMB Bylaws Committee will meet on September 26 to consider requests for amendments or revisions to the FSMB Bylaws.

Licensure Update

Licensure Committee provided an update on Overview, Database Installation, FSMB pilot project for maintenance of license, Midwest Licensure Portability Task Force, State Advisory Panel to the USMLE and the Licensure Committee report.

The Board granted five permanent licenses, five licenses left open for additional information and one withdrawal of licenses.
