Siroos Shirazi, M.D., called the teleconference to order at 7:39 a.m.

On a motion by Tom Drew, and a second by Colleen Stockdale, M.D., the Board voted unanimously to go into closed session at 7:39 a.m., pursuant to Iowa Code Section 21.5(1)(a). Diane Clark, Tom Drew, Analisa Haberman, D.O., Ambreen Mian, Siroos Shirazi, M.D., Jeff Snyder, M.D., Colleen Stockdale, M.D., Hamed Tewfik, M.D., and Joyce Vista-Wayne, M.D., voted aye. Hoversten entered the meeting at 7:40 a.m. At the conclusion of the closed session, the Board voted to go into open session at 7:49 a.m. Kent Nebel, Director of Legal Affairs, presented the following cases to the Board in open session:

I. Consideration of a Settlement Agreement in the Matter of Michael F.E. Jones, M.D., File No. 02-10-596

On a motion by Diane Clark, and a second by Hamed Tewfik, M.D., the Board voted to **approve** the Settlement Agreement of Michael F.E. Jones, M.D. File No: 02-10-596. (Hoversten recused)

II. Consideration of a Statement of Charges in the Matter of Andrew J. Stefani, D.O., File No. 03-11-024

On a motion by Siroos Shirazi, M.D., and a second by Joyce Vista-Wayne, M.D., the Board voted to **approve** the Statement of Charges in the Matter of Andrew J. Stefani, D.O., File No. 03-11-024.

III. Executive Director's Report

Mark Bowden reported that four physician members are needed for the hearing panel to be seated on May 9 and 10, 2012. He asked physician Board members to review their schedules to see if they would be available. He said two of the physicians could be Alternate members.

The Governor's Office has not announced appointments for the successors for Tom Drew and Analisa Haberman, D.O. Drew is resigning from the Board on April 30, and Haberman's term expires April 30. Governor Branstad appointed Julie Perkins, M.D., Carroll, to the Board to succeed Siroos Shirazi, M.D., whose term expires April 30. Perkins has received Senate confirmation. Colleen Pasnik, Dubuque, was appointed to succeed public member Ambreen Mian, whose term expires April 30. Pasnik is awaiting Senate confirmation.

New member orientation will be held in late April.

The Legislature has approved two bills and they are now awaiting action by Governor Branstad, who is expected to approve the two bills. The first bill allows a physician to supervise up to five physician assistants (PAs), concurrently, versus the present limit of up two PAs. The other bill permits PAs and advanced registered nurse practitioners to prescribe respiratory care to patients. Bowden said the PA supervision legislation would be discussed at the April 19-20, 2012, Board meeting.

The meeting adjourned at 7:52 a.m.
