Frank Bognanno, Diane Clark, Ann Gales, Greg Hoversten, D.O., Julie Perkins, M.D., Colleen Stockdale, M.D., Hamed Tewfik, M.D., Michael Thompson, D.O., and Joyce Vista-Wayne, M.D., all voted aye in a roll call vote to approve the motion. At 7:42 a.m., while still in a closed session, all members present voted in favor of a motion by Colleen Stockdale, M.D., seconded by Hamed Tewfik, M.D., to meet in an open session. The Board took the following action in the open session:

### **Executive Director's Report**

The Executive Director Mark Bowden provided a written report to update the Board on several items:

**Noticed amendments to 653 Iowa Administrative Code Chapters 22 and 23.** These rules establish an obligation for physicians to report to the Board all actions involving their hospital privileges and establish grounds for discipline if a physician fails to make such a report. Bowden noted the Iowa Medical Society has expressed doubt that the Board has statutory authority to require these reports. The Administrative Rules Review Committee reviewed the proposed amendments on July 10, 2012. A public hearing on the amendments will be held at 11 a.m., July 17, 2012.

**Adopted amendments to the Board's licensure rules, Chapters 9, 10, and 11.** These amendments have been filed with the Administrative Code Office for publication on July 25, 2012. They will become effective on August 29, 2012.

**Annual regulatory plan.** The Board's annual plan for potential regulatory actions (new rules and rule amendments) is due in the Governor's office by August 1, 2012. The plan is a list of potential rule changes, subject to revision as the Board's priorities change and new issues appear. The current plan is on the website, [www.medicalboard.iowa.gov](http://www.medicalboard.iowa.gov) and is published on page 14 of the Board's 2011 Annual Report.

**Ad hoc committee to review potential legislation regarding roles of administrative law judges and the presence of alternate members in contested-case hearings.** The committee met via telephone on July 7, 2012. Board member Joyce Vista-Wayne, M.D., chairs this committee. Kent Nebel will prepare materials for the Board to consider at the July 26-27, 2012, Board meeting.

**Ad hoc committee to review the expectations for physicians who supervise physician assistants.** This committee is expected to hold a meeting via telephone prior to the July 26-27, 2012, Board meeting. Board Vice-Chair Jeff Snyder, M.D., chairs this committee.

**Public meeting in Council Bluffs.** The Board will hold its annual traveling meeting on July 26-27, 2012, in Council Bluffs, Iowa. A public session will be held at 3:00 p.m., on Thursday, July 26, 2012 at the Mid America Center, Room H.

**Board member orientation.** An orientation for new Board member Ann Gales was held July 10.
