At 1 p.m., Colleen Stockdale, Chair, called the meeting to order. A roll call was taken to establish a presence of a quorum of the Board. Frank Bognanno was not present. On a motion by Hamed Tewfik, M.D., and a second by Jeffrey Snyder, the Board unanimously approved the agenda as presented.

A. Opportunity for public comments

Jeannie Freeman, Iowa Medical Society (IMS) commented on legislation proposed by the Board:

- IMS is not supportive of legislature that would require physicians to review a patient's controlled substance prescription history before writing a controlled substance prescription if the physician suspected the patient is at risk of abuse or diversion of controlled substances.
- IMS is not supportive of legislature that would allow an administrative law judge to oversee certain contested hearings without Board members present.
- IMS is not supportive of legislature increasing the maximum amount of a civil penalty from \$10,000 to \$20,000 per charge.
- IMS is supportive of allowing an increase of alternative board members allowed to participate in a hearing.

Leah Williams from Iowa Osteopathic Association (IOMA) had concerns regarding the wording in several purposed rule changes.

Dr. Stockdale encouraged IMS and IOMA to work with Board staff to see if compromise language was possible on the proposed amendments to Iowa Code Chapter 148.

C. Chair's report

Dr. Stockdale did not provide a report.

D. Executive Director's report

Mark Bowden, executive director, provided the following updates:

- Jennifer Huisman has been hired as an investigator and she will start January 18, 2013. Ms. Huisman is an investigator in the Iowa Department of Inspections and Appeals. She will fill the vacancy caused by Ed Knapp's retirement last fall.
- Teena Turnbaugh, the executive director's secretary, retired at the end of 2012.
- Blaine Houmes, M.D., an Alternate member since March 2009, resigned at the end of 2012.
- John Marshall, M.D., an internist from Council Bluffs, has been appointed as an Alternative member.
- Jeffrey Snyder, M.D., a Board member since 2008, is not seeking reappointment to the Board. He would like to serve as an Alternate member. On a motion by Hamed Tewfik, M.D., and a second by Diane Clark, the Board voted unanimously to recommend the appointment of Dr. Snyder to the Alternate pool when his Board term expires April 30, 2013. Mr. Bowden was instructed to notify the Governor.
- New database is scheduled to be ready by the end of June 2013.
- The FSMB meeting is April 18-20 in Boston, MA. Mr. Bowden asked Board members to review FSMB materials and express their interest in attending by mid-February so the appropriate travel authorization request forms can be completed.

E. Legislative update

Mr. Bowden noted that the 85th General Assembly convenes Monday, January 14, 2013. Legislative issues that may of interest to the Board will likely include medical marijuana, Medicaid expansion, free standing ambulatory surgical center, and changing from county to regional for mental health services.

The Board is proposing amendments to Iowa Code Sections 124 and 148:

- Require physicians to review a patient's controlled substance prescription history, as recorded in the Iowa Prescription Drug Monitoring Database, before writing a controlled substance prescription if the physician suspects the patient is at risk of abusing or diverting controlled substances.
- More aggressive use alternative board members in contested case hearings
- Raise the cap on civil penalties from \$10,000 to \$20,000 and providing language on the application (per count or per charge) of that fee.
- Allow the Board to assign non-medical competency cases to be heard by an administrative law judge (ALJ).

Dr. Hoversten proposed a change to the wording as to when cases will be assigned to ALJs. He encouraged more language to define the types of cases that could be assigned. On a motion by Joyce Vista-Wayne, M.D., and a second by Dr. Tewfik, the Board directed Mr. Bowden and Mr. Nebel to revise the amendment to address Dr. Hoversten's concern. Mr. Bowden said given the deadline for filing the legislation, he would send the revised proposal to the Executive Committee only for review.

F. Administrative rules (updates)

Mr. Bowden briefed the Board on the new administrative rules that require physicians to personally report to the Board disciplinary actions taken against their hospital privileges or if a physician surrenders or restricts their privileges to avoid disciplinary actions taken against their hospital privileges. These rules are effective January 30, 2013:

1. Filed – ARC 0532C (653 - Chapter 22.5). Mandatory reporting of hospital action against a licensee's privileges
2. Filed – ARC 0533C (653 - Chapter 23.1(48). Grounds for discipline for failure to report hospital action.

G. Update on ad hoc committee looking at expectations for physicians who supervise physician assistants.

Dr. Snyder, chair of the committee, said the staff will develop a press release that expresses the Board's expectations for physicians who supervise physician assistants. Mr. Bowden will present the press release at the March 78-, 2013, Board meet for review and approval.

H. Recognition of equivalents to Category 1 CME credits for 2012 Board service: Members and Alternates, members of the Iowa Physician Health Committee, and physicians who perform peer reviews for the Board.

On a motion by Dr. Tewfik and a second by Dr. Vista-Wayne, the Board accepted the Executive Committee's recommendation of granting CME equivalent hours on a per-hour service. Mr. Bowden said physicians eligible for the recognition will be notified

I. Reports

- Citizen Advocacy Center annual meeting, October 25-26, 2012. Ms. Gales attended the meeting. She said this group supports public members who serve on a variety of state health regulatory boards. Twenty-three states were represented with 80 attendees. Wide variety of topics including mandatory reporting and the PMP were discussed. Ms. Gales said the meeting will help her as a new member of the Board of Medicine.
- 21st National Conference on Pharmaceutical and Chemical Diversion, November 14-15, 2012. Chief Investigator Russell Bardin attended the conference. He said prescription drugs and meth are the biggest problem for Drug Enforcement Administration. Prescription drug overdose was double than cocaine and heroin combined. The Prescription Monitoring Program has been valuable to divert overprescribing.
- American Association of Osteopathic Examiners' summit, January 4-5, 2013. Michael Thompson, D.O., attended the summit. Topics discussed included abuse and diversion of prescriptions, NBOME's plans to integrate into the ACGME accreditation system, medical marijuana, telemedicine, and re-entry to practice.

J. Licensure

- Amy Van Maanen, director of licensure, provided a brief update on maintenance of Licensure. She said results of the first pilot project – state board readiness to

implement an MOL - are not conclusive. She said the next pilot project is on physician acceptability of MOL.

- The Licensure Committee granted 3 permanent licenses: approved granting 1 permanent medical license upon successfully completing 24 months of training in April; approved granting 1 permanent medical license per the Iowa Physician Health Committee's (IPHC) recommendation; and approved granting 1 acupuncture license per IPHC's recommendation
- Committee recommended the Board consider the waiver of the renewal fee for Iowa-licensed physicians who are in active duty in U.S. Armed Forces. Staff will draft rules and start the rule making process at the March board meeting.

K. Enforcement

An updated was provided by Russell Bardin, chief investigator, on physicians who are under board orders that work/live outside of Iowa. He reinforced those physicians who practice outside Iowa or move outside Iowa are still required to fulfill board orders. A memorandum on the Board's practice, prepared by Mr. Bowden, will be posted on the Board's website.
