Hamed Tewfik, M.D., chair, called the meeting to order at 9:06 a.m. Dr. Tewfik recognized a quorum of the Board was present. The following items were addressed:

**Introduction of New Assistant Attorney General:**

Assistant Attorney General Julie Bussanmas introduced Jordan Esbrook, an assistant attorney general, assigned to the Board to succeed September Lau, who resigned.

**Opportunity for Public Comment:**

Two members of the public spoke to the Board at the time the items were addressed on the agenda. (See entries elsewhere in these minutes.)

**Board Minutes for Consideration of Approval:**

On a motion by Frank Bognanno, seconded by Ronald Cheney, D.O., the Board unanimously approved the following minutes as presented:

**Chair's Report:**

Dr. Tewfik did not provide a report.

**Executive Director's Report:**

Mark Bowden provided the following updates:

- The Board is working to fill the open position of Secretary 3, made vacant by the promotion of Natalie Sipes to the Director of Licensure.
- Currently accepting bids to create a mobile application for the Board's 'Find a Physician' feature, which is the top used tool on the Board's website.
- No hearings are scheduled for August or September. Kent Nebel, Director of Legal Affairs, has continued to be successful in securing settlement agreements, reducing the number of hearing.
- Beginning on July 1 the new law allows the Board to use more Alternate members for hearing panels.
- The Governor has not made a selection for a successor to former Board member Robert Bender, M.D.

**Administrative Rules & Potential Legislation:**

- Amendments to 653 IAC Chapter 13, "Standards of Practice and Principles of Medical Ethics," to establish standards of practice for physicians who use a real-time interactive telecommunication system to diagnose and treat patients. Kent Nebel, director of legal affairs, shared an overview of the draft telemedicine rules, which were provided to the Board. The executive committee discussed the proposed rules at the Thursday, August 7

committee meeting and recommended the Board request written responses from interested parties, followed by a joint meeting with stakeholders and available Board members. Mr. Nebel will then edit and finalize the proposed rule for the Board to considering adopting at the October 2-3, 2014, meeting.

- Notice of Intended Action: Establish 653 IAC Chapter 18, “Military Service and Veteran Reciprocity,” to engage the Governor’s Home Base Iowa Act initiative for licensure (medical and acupuncture) of military veterans, allowing credit for military training and experience in the licensure process, issuance of a provisional license, and licensure by reciprocity/expedited endorsement. On a motion made by Allison Schoenfelder, M.D., and a second by Diane Clark, the Board voted unanimously to approve the notice of intended action.
- Iowa Board of Physician Assistants’ may pursue possible rule-making to rescind a subrule that requires a physician to visit their PAs who work in remote clinics at least once every two weeks. The chair of the physician assistants’ Board asked the Iowa Board of Medicine to select Board members and staff to meet and discuss the potential change to the rule. Ronald Cheney, D.O. and Allison Schoenfelder, M.D. volunteered to participate in the discussion with the physician assistants’ Board. Mark Bowden, executive director, will set up the discussion to coincide with the October Board meeting.
- Mark Bowden presented the Board’s FY 2015 regulatory plan, which lists potential rule-making the Board may pursue over the next year. Mr. Bowden offered examples of 2014 regulatory action that has come about. He said regulatory plans are not set in stone, but can be updated throughout the year. The plan is posted on the Board’s website and was submitted to the Governor.

### **2015 Legislative Agenda**

- **Acupuncture licensure and regulation** – Kent Nebel reviewed the staff’s ongoing effort to update the rules and laws regarding acupuncture, which were originally written 15 years ago. Staff is working to update definition of acupuncture, update the national societies, etc. Beyond that, the Iowa Acupuncture Association has approached the Board about a more comprehensive update to the rules. William Terrell, L.Ac., spoke on behalf of the Iowa Acupuncture Association. The Board chose to table the discussion until the October Board meeting.
- **Administrative medical license** – A proposed legislative change would allow the Board to issue an administrative license to a physician who would not be in clinical practice. Many states have an administrative license for non-clinical practice. This type of license has been on the Board’s regulatory plan since 2012. The Board expressed support of pursuing this legislation.
- **Civil penalties** – Legislation was unanimously approved by the Senate in 2013, but it stalled in the House at the end of the 2013 session. It was pursued again in the House in 2014, but did not gain enough support to pass the State Government Committee. Current law allows civil penalties of up to \$10,000 per case. The change would allow for

\$10,000 per count with a maximum of \$25,000 per case. The Board expressed support of pursuing this legislation.

- **Interstate medical licensure compact** – The compact will allow portability of medical licenses if the physicians meet the standards established in the compact. The compact would preserve the state-based licensure system. The compact will require states wishing to participate in the compact to adopt identical legislation. The Board expressed support of pursuing this legislation.
- **Relinquish inactive medical license** – At the Board’s request, staff drafted legislation and corresponding rules that outline non-disciplinary surrender of a license if a licensee doesn’t reinstate their license for five years. Currently, the Board can take reciprocal action on an inactive license, when the licensee has been disciplined by other state licensing Boards regardless of how long the license has been inactive. The Board expressed support of pursuing this legislation.
- **Use of administrative law judge to hear certain cases** – Legislation was offered in 2013 that would allow use of administrative law judges to hear certain defined cases without a panel of Board members present. The bill was unanimously passed by the Iowa Senate, but stalled in the House at the end of the 2013 session. The bill was reconsidered by the House in the 2014 session, but it faced opposition from the Iowa Bar Association, which was concerned about the legality of the legislation. Use of administrative law judges in this way is common across the U.S. Mark Bowden will meet with Bar Association representatives to discuss their concerns. The Board expressed support of pursuing this legislation.
- **Use of PMP database when prescribing controlled substances** – Legislation was proposed in 2013 that would require physicians prescribing controlled substances to use the Prescription Monitoring Program database if they suspect patients are abusing or diverting prescriptions. The legislation did not pass. Mark Bowden will meet with the Governor’s Office of Drug Control Policy to determine if that office would help support the legislation in 2015.

Michael Thompson, D.O., joined the meeting at 10:28 a.m.

### **Petition for Waiver**

Mercy Cardiology Clinic in Cedar Rapids petitioned the Board for a variance of its rules regarding collaborative agreement between physicians and pharmacists. Jamie Sinclair spoke on behalf of Mercy Medical Center. Mercy is requesting that physicians who are employed not have to sign the agreement because it has been approved thru their medical staff approval body. Physicians who are not employees, but choose to refer their patients to the clinic would still be required to sign the agreement.

Mercy Medical Center also requested a second waiver. The community collaborative agreement prohibits the authorized pharmacist from delegating drug therapy management to anyone other

than the pharmacist. This language does not exist in the hospital based collaborative agreement. They are asking that the community agreement function the same way as the hospital agreement.

The Board determined they would be willing to grant the first waiver. The Board requested more communication with the Pharmacy Board before making a decision on the second waiver.

### **Legal Update on Judicial Review of Board Cases and Related Cases:**

Assistant Attorney General Julie Bussanmas briefed the Board on six cases under judicial review in state courts:

**IAC 653 13.10** – Standards of practice for physicians who perform medical abortions. Oral arguments were held June 16 and the Board is awaiting the District Court's decision on the judicial review of the rule.

**Amjad Butt, M.D.** – Dr. Butt has two cases awaiting review in District Court. Both cases have been argued and submitted and are awaiting decision.

**Mark Collison, M.D.** – Dr. Collison is awaiting a decision on respondent's application for further review by Supreme Court.

**Donna DeLouis, D.O.** – The case has been briefed with Appeals Court.

**Richard Fleming, M.D.** – District court affirmed the Board's decision. Dr. Fleming appealed to the Supreme Court.

**Wendy Smoker, M.D.** – The District Court dismissed her claim for expenses, finding that Dr. Smoker should have raised this in the first appeal of her disciplinary case and should have asked for a stay.

### **Iowa Physician Health Program:**

Amy Van Maanen, IPHP project manager, presented a report on the Iowa Physician Health Program. The program is working with 83 participants. The annual Board member and Iowa Physician Health Committee member luncheon is tentatively scheduled for September 12, 2014.
