Dear Senator Slater and Representative Swartz:

This report is submitted in compliance with Section 258A.4(2) of the Code of Iowa.

A. The Board of Medical Examiners filed its rules relating to the duties of the Board on November 29, 1978, and these rules became effective on March 29, 1979.

Administrative rules adopted in 1983 relating to the duties of the Board of Medical Examiners are as follows:

1. Health 470-135 (147 and 258A) "Medical Examiners". Rules provide for biennial licensure, renewal, and reporting of continuing medical education according to month and year of birth coincidental to odd-even years and adjusts fees accordingly. These rules also satisfy the requirements of multi year renewal of licenses. Effective date was April 28, 1983.
2. Health 470-135.102 and 108 (147) "Medical Examiners". Rules relative to the federation licensing examination (FLEX) define subversion and more clearly indicate Board actions in the event of subversion of the exam. This change also permits senior medical students from the University of Iowa and the University of Osteopathic Medicine and Health Sciences to take the FLEX. Effective date was September 7, 1983.
3. Health 470-132.12 (147A) "Advanced Emergency Medical Care". Extended the date of the EMT-D pilot study program to December 31, 1984, and allows the training of certain individuals to use an automatic defibrillator. Results of manual and automatic defibrillation will be compared to determine the efficacy of the automatic device. This change also allows all authorized advanced care training programs to provide EMT-D manual training. Effective date was September 21, 1983.

4. Health 470-135.110, 204 and 301 (17A, 147, 258A) "Medical Examiners". Rules set out procedures and requirements for re-instatement of lapsed licenses. The change also sets a maximum fee for reinstatement of a lapsed license. One portion of these rules allow the Board to review a decision or order of a hearing officer or three member panel provided all parties are notified of such action within thirty days of the motion to reconsider. Effective date of the rules was November 2, 1983.
