EXECUTIVE DIRECTOR'S REPORT

The members and staff of the Iowa Board of Medicine are committed to protecting the health of Iowans through the judicious licensure and regulation of physicians and acupuncturists. The important work of this state agency falls into three broad categories: licensure, enforcement and rule-making.

At the end of 2010, the Board was administering licenses for 10,593 physicians, up 218 from 2009, and 41 for acupuncturists, unchanged from the previous year. A total of 657 complaint files were opened, down from 681 in 2009. Charges were filed against 27 physicians, down from 45 in 2009. There were 183 physicians under disciplinary monitoring.

The Board established five new administrative rules in 2010 to define additional standards of practice and to address regulatory issues.

Two ad hoc committees composed of Board members, staff and stakeholders were seated in 2010 to advise the Board on issues pertaining to patients' abuse and diversion of prescribed medications and physicians' use of video-teleconferencing in the practice of medicine.

Administratively, the Board had to comply with directives to reduce expenditures amid a downturn in state revenue. Although the Board does not receive a general fund appropriation and is funded exclusively with licensure fees, this agency was included in an executive order for staff furloughs and restrictions on hiring and operating expenditures.

Organization

In April, Siroos Shirazi, M.D., Iowa City, was elected Board chair, Rodney Zeitler, M.D., Iowa City, vice chair, and Janice Galli, D.O., secretary. On May 1, Joyce Vista-Wayne, M.D., Ottumwa, joined the Board, succeeding Yasyn Lee, M.D., Dubuque, whose term expired on April 30.

Budget

In June, the Board approved a spending plan of \$3,143,776 for fiscal year 2011 (July 1, 2010, through June 30, 2011), up from \$3,030,355 in FY 2010. The increase included state-defined incentives for an early retirement program, pay raises for staff members covered by bargaining contracts, and additional expenses for state services performed for

the Board by other state agencies and departments. The Board also budgeted for capital improvements, such as a new database.

Personnel

In March, the Board hired an investigator to fill a vacancy, and in April the Board received notice that four of its seven investigators were taking early retirement and would be departing by July 1. Three investigators were hired in December. A licensure staff member retired in April, and that position was left open.

Hearings

The Board established a schedule for hearing dates in 2010 and 2011, making it easier for members to plan for assignments on hearing panels. Not all hearings can conform to the schedule, but it's a first step toward ensuring timely hearings. Three hearings were held in 2010.

Alternates

Alternate Board members continue to play an important role in hearings. Up to two Alternates can serve on a six-member panel for a hearing when a quorum (majority) of the 10-member Board is not available. Since it was authorized by law in 2008 and implemented in 2009, the Alternate pool is routinely tapped for hearings. In July, Janece Valentine of Fort Dodge was appointed to the pool. Other Alternates in 2010 were Blaine Houmes, M.D., Cedar Rapids, Dana Shaffer, D.O., Exira, and Allen Zagoren, D.O., Clive. All Alternates are former Board members.

Technology

Work continued throughout 2010 on the installation of a new database to house the Board's records on licensure and discipline and to improve the public's access to the public information managed by the Board. The database, a collaborative project involving Medicine, Nursing and Dental boards, is expected to be operational in the spring of 2011. The project's cost of \$1.8 million will be shared by the three boards and a grant from the IowAccess Council. In May 2010, the Board received a \$10,000 federal grant to help cover software costs to program the Federation of State Medical Boards' uniform physician licensure application into the database. Also in 2010, the Board made significant upgrades in office computers and other technology.

Outreach

In April, the Board's website, www.medicalboard.iowa.gov, was redesigned to improve public and licensees' access to information. The website attracts 10,000 visitors per month from 50 countries. A popular draw to the site is the licensee database, which can be searched by name and specialty. The database includes public disciplinary actions against a licensee. The redesigned website supported an increase in the number of press releases about the Board's work in licensure, enforcement and rule-making. The staff also worked to raise the Board's profile by making more presentations to the public, licensees, and health care organizations and associations.

This is a summary of some of the activities the Board has been involved with in 2010. More information about the Board's work is available in the agendas, minutes, reports and press releases on the website, www.medicalboard.iowa.gov, and on the Board's page on Facebook. Much has been accomplished in the past year, but much more remains to be done. The Board looks forward to the many challenges that lie ahead and will continue its efforts to protect the health of Iowans.

THE BOARD

The Iowa Board of Medicine is an executive branch agency charged with the licensing and regulation of physicians (practitioners with a doctor of medicine degree or a doctor of osteopathic medicine degree) and acupuncturists. The 10-member Board is composed of seven physicians (five M.D.s and two D.O.s) and three non-physicians who represent the public. Members are appointed by the Governor and confirmed by the Senate for a full three-year term or to complete the unexpired term of a member who resigned. Members can serve up to nine years.

The Iowa Physician Health Program was established in 1996 to support physicians who self-report mental health issues, physical disabilities or substance use disorders. The confidential monitoring program is administered by the Iowa Physician Health Committee, which is appointed by the Board. The committee meets six times per year. Staff members of the Board manage the program. Participants are under contract.

ADMINISTRATIVE RULES

The following administrative rules were established by the Iowa Board of Medicine in 2010:

Chapter 2, Public Records and Fair Information Practices – ARC 9089B

The amendments update language in subrules 2.13(2) and 2.13(4) to clarify what is a confidential record and to allow the Board to share information with the Department of Revenue and the College Student Aid Commission in certain circumstances.

Chapter 13, Standards of Practice – ARC 8579B

This new rule, 13.9, establishes standards of practice for interventional chronic pain management. The purpose of this rule is to assist physicians who consider interventional techniques to treat patients with chronic pain.

Chapter 13, Standards of Practice - ARC 8925B

Rule 653—13.8(148,272C) establishes the standards of practice for a physician who serves as a medical director at a medical spa.

Chapter 14, Iowa Physician Health Committee – ARC 8751B

Amendments in subrule 14.9(1) and 14.9(4) allow for the sharing of physician health program participant information with the Board if a participant's information held by the Physician Health Committee indicates that a significant risk to the public exists.

Chapter 23, Grounds for Discipline – ARC 8925B

Subrules 23.1(43) and 23.1(44) establish as grounds for discipline improper delegation and supervision with regard to the standards of practice for a physician who serves as a medical director at a medical spa.
