Colleen Stockdale, M.D., called the meeting to order at 7:34 a.m.

At 7:34 a.m., on a motion by Diane Clark, seconded by Hamed Tewfik, M.D., all members present voted to meet in a closed session, pursuant to Iowa Code Section 21.5(1)(a). Frank Bognanno, Diane Clark, Julie Perkins, M.D., Jeff Snyder, M.D., Colleen Stockdale, M.D., Hamed Tewfik, M.D., and Michael Thompson, D.O., all voted aye in a roll call vote to approve the motion. Board member Frank Bognanno dropped off the teleconference at 7:45 a.m. At 7:50 a.m., while still in a closed session, all members present voted in favor of a motion by Colleen Stockdale, M.D., seconded by Hamed Tewfik, M.D., to meet in an open session. The Board took the following action in the open session:

### **Executive Director's Report**

Mark Bowden stated he is awaiting the Governor's appointment of a new Board member to complete the unexpired term (one year) of Tom Drew, who resigned April 30. Board orientation was held on April 23 for Drs. Julie Perkins and Michael Thompson, and on May 16 for Frank Bognanno.

The Board approved the Notice of Intended Action to amend 653 Iowa Administrative Code Chapters 9, 10 and 11 on March 2, 2012. A public hearing was held on May 8, 2012, to discuss the amendments to these licensure rules. Leah McWilliams, Executive Director, Iowa Osteopathic Medical Association, attended and provided comments. The amendments will be presented for adoption at the June 8, 2012, Board meeting.

The Board approved the Notice of Intended Action to amend Chapter 22, Reporting hospital action, and Chapters 23, Grounds for discipline for failure to report hospital action, on April 19, 2012. These amendments will be reviewed by the Governor's Office before they are formally submitted for publication in the Administrative Rules Bulletin.
