This special teleconference was held to finalize the hearing decision regarding Michael C. Prescher, M.D., File Nos. 02-09-323 and 02-10-180. As directed by the Board, Administrative Law Judge Jeffrey Farrell prepared the findings of fact, conclusions of law, decision, and order for review by the Board.
