

**YOU ARE HEREBY NOTIFIED, PURSUANT TO IOWA CODE SECTIONS  
272D.8, 272D.9 and 653 IAC 12.3 and 23.1(40), THAT:**

1. The Iowa Board of Medicine (Board) intends to suspend your Iowa medical license (27178) due to the Board's receipt of a certificate of noncompliance from the Iowa Department of Revenue Centralized Collection Unit (Unit).
2. You must contact the Unit at the address or telephone number provided on the certificate of noncompliance to schedule a conference or otherwise obtain a withdrawal of the certificate of noncompliance.
3. Unless the Unit furnishes a withdrawal of the certificate of noncompliance to the Board within thirty (30) days of the issuance of this notice, your Iowa medical license (27178) will be suspended.
4. Pursuant to 653 IAC 12.3(2), the effective date of the suspension of license, as specified in the notice required by Iowa Code section 272D.8, shall be sixty (60) days following the issuance of this notice upon the licensee.

5. Pursuant to 653 IAC 12.3(4), you are required to keep the Board informed of all court actions taken by the Unit by providing copies to the Board within seven (7) days of filing or issuance, of all application filed with the district court pursuant to Iowa Code section 272D.9, all court orders entered in such actions, and withdrawals of certificate of noncompliance by the Unit.

6. You do not have a right to hearing before the Board, but you do have the right to contest this Notice by requesting a court hearing pursuant to Iowa Code section 272D.9, within thirty (30) days of service of this Notice.

**TAKE NOTICE AND GOVERN YOURSELF ACCORDINGLY**

Notice issued this 25<sup>th</sup> day of August, 2010 by restricted, certified mail, return receipt requested, to Genesis Health Group, 2560 24<sup>th</sup> Street, Suite 202, Rock Island, IL 61201.
