CONSENT AGREEMENT


COME NOW the Iowa Board of Medicine (hereinafter "the Iowa Board") and John Berger, D.O. (hereinafter "Applicant") on 9 July, 2010, and hereby enter into the following Consent Agreement for the issuance of a permanent medical license under the following terms and conditions:

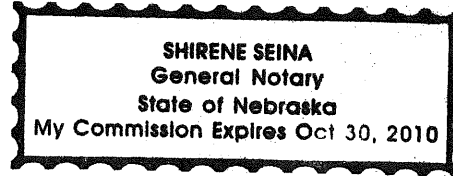
1. Applicant is hereby granted Iowa permanent license no. 4095 to practice medicine and surgery in Iowa.
2. Applicant is an internal medicine resident in Nebraska expected to complete training on June 30, 2010.
3. Applicant applied for a permanent Iowa medical license on January 27, 2010.
4. In July 2007, Applicant was issued a Nebraska temporary license and placed on probation for substance abuse.
5. In May 2009, Applicant was issued a Nebraska permanent license and placed on probation for substance abuse.

6. Applicant has been compliant with the terms of his probation in Nebraska.
7. As a condition of Iowa licensure, Applicant shall enter into a contract with the Iowa Physician Health Program for monitoring.
8. Applicant shall comply with all provisions of the contract with the Iowa Physician Health Program.
9. Applicant shall obey all federal, state and local laws, and all rules governing the practice of medicine in Iowa.
10. This Consent Agreement constitutes the resolution of a contested case proceeding.
11. Applicant voluntarily submits this Consent Agreement to the Iowa Board for consideration.
12. In the event Applicant violates or fails to comply with any of the terms or conditions of this Consent Agreement, the Iowa Board may initiate action to suspend or revoke the Applicant's Iowa medical license or to impose other license discipline as authorized in Iowa Code chapters 148 and 272 and 653 IAC 25.
13. By entering into this Consent Agreement, Applicant voluntarily waives any right to a contested case hearing in this matter.
14. This Consent Agreement is subject to approval of the Iowa Board. If the Iowa Board fails to approve the Order, it shall be of no force or effect to either party.

15. The Iowa Board's approval of this Consent Agreement shall constitute a

FINAL ORDER of the Iowa Board.


