CONSENT AGREEMENT

COMES NOW the Iowa Board of Medicine (Board) and Catherine M. Hansen, D.O., (Applicant), on December 15, 2017, and enter into this Consent Agreement for the issuance of an Iowa resident license subject to the following terms and conditions:

1. Applicant is hereby granted Iowa resident license number R-11067 on December 15, 2017 to participate in a family medicine residency at Cedar Rapids Medical Education Foundation beginning in January 2018.

2. On October 3, 2017, Applicant submitted an application for an Iowa resident license. Applicant previously held Iowa resident license R-09574.

3. Improper Management of Medical Records/Violation of Patient Privacy Standards: Applicant is charged pursuant to Iowa Code sections 148.6(i) and 653 IAC 23.1(36) with improper management of medical records and violation of patient privacy standards.

4. Improper Management of Medical Records/Violation of Patient Privacy


Standards: Applicant improperly managed medical records when she disclosed patients' personally identifiable health information that she obtained during her previous residency training in Cedar Rapids, Iowa, in 2013, in violation of patient privacy standards.

5. **CITATION AND WARNING:** Applicant is hereby **CITED** for improperly managing medical records when she disclosed patients' personally identifiable health information that she obtained during her previous residency training in Cedar Rapids, Iowa, in 2013, in violation of patient privacy standards. Applicant is hereby **WARNED** that engaging in such conduct in the future may result in further disciplinary action against her Iowa medical license.

6. **CIVIL PENALTY:** Applicant shall be assessed a **\$2,500 civil penalty**. The civil penalty shall be payable to the Treasurer of Iowa, shall be mailed to the executive director of the Board and shall be deposited into the State General Fund.

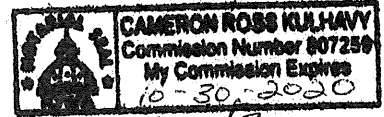
7. **PROFESSIONAL ETHICS PROGRAM:** Applicant shall successfully complete the Professional/Problem Based Ethics (PROBE) program sponsored by the Center for Personalized Education for Physicians (CPEP), 7351 Lowry Blvd., Suite 100, Denver, CO 80230, 303-577-3232, within ninety (90) days of the date of this order. Applicant shall ensure that a report is sent directly to the Board. Applicant is responsible for all costs associated with the program.


8. Applicant voluntarily submits this Order to the Board for consideration.
9. Applicant agrees that the State's counsel may present this Order to the Board for consideration.
10. By entering into this Order, Applicant understands that she has the right to legal counsel in this matter and waives any objections to the terms of this Order.
11. Applicant shall obey all federal, state and local laws, and all rules governing the practice of medicine in Iowa.
12. Applicant understands that by entering into this Consent Agreement, she cannot obtain a copy of the investigative file. Pursuant to Iowa Code section 272C.6(4), a copy of the investigative file may only be provided to a licensee after a Statement of Charges is filed but before the final resolution of those charges.
13. Applicant understands that the Board is required by Federal law to report this Order to the National Practitioner Data Bank.
14. This Order becomes a public record available for inspection and copying upon execution in accordance with the requirements of Iowa Code Chapters 17A, 22 and 272C.
15. This Order is subject to approval of the Board. If the Board fails to approve this Order it shall be of no force or effect to either party.
16. The Board's approval of this Order shall constitute a **Final Order** of the Board.


