STIPULATED ORDER – AGREEMENT NOT TO PRACTICE MEDICINE

COMES NOW the Iowa Board of Medicine (Board) and Sascha R. Parsons, M.D. (Respondent) on June 8, 2018, and pursuant to Iowa Code sections 17A.10 and 272C.3(4)(a), enter into this Stipulated Order – Agreement Not to Practice Medicine.

1. **Iowa Medical License:** Respondent was issued Iowa medical license MD-33461 on April 17, 2000. Respondent's Iowa medical license is active and will next expire on September 1, 2019.
2. **Jurisdiction:** The Board has jurisdiction in this matter pursuant to Iowa Code Chapters 147, 148 and 272C.
3. **Practice Setting:** Respondent is an Iowa-licensed physician who formerly practiced family medicine in Boone, Iowa.

4. **Health Condition:** Recently, the Board received information which indicates Respondent may suffer from a health condition which impairs her ability to practice medicine with reasonable skill and safety.

5. **Agreement Not to Practice Medicine:** Respondent voluntarily agrees that she shall not engage in any aspect of the practice of medicine under her Iowa medical license until this matter is resolved. Respondent may seek to return to the practice of medicine under her Iowa medical license by demonstrating to the Board that she does not suffer from a health condition which impairs her ability to practice medicine with reasonable skill and safety.

6. Respondent voluntarily submits this Stipulated Order to the Board for consideration.

7. Respondent agrees that the State's counsel may present this Stipulated Order to the Board for consideration.

8. Respondent understands that by entering into this Stipulated Order she has a right to legal counsel in this matter and waives any objections to the terms of this Order.

9. Respondent understands that the Board is required by Federal law to report this Stipulated Order to the National Practitioner Data Bank.

10. Respondent understands that this Stipulated Order becomes a public record available for inspection and copying upon execution in accordance with the requirements of Iowa Code Chapters 17A, 22 and 272C.

11. This Order is subject to approval by the Board. If the Board fails to approve this Order, it shall be of no force or effect to either party.


12. The Board's approval of this Order shall constitute a **Final Order** of the Board.
